And also after careful examination of the references cited and the conditions prescribed in G.O.Ms.No.1 Education, Dt.01.01.1994, and also subsequent government orders from time to time, the competent authority is hereby grants Renewal of Recognition to Global View School, Sri Balaji Green City, Opp. Chokkapu Cheruvu, Rambhadrapuram Mandal, Vizianagaram District under Buddha Educational Society, Mallamma peta, Bobbili for period of 8 (Eight) years commencing from the academic year 2023-2024 to 2030-2031 to the classes I to VII(EM) subject to fulfill the following conditions without Grant in Aid.

- 1. That the Educational Institution should abide by the instructions/rules and regulations made by the Government or authorised officer time to time.
- 2. That the Educational Institution should observe the needs of the locality
- 3. Inat the Institutions should adopt the curricula and Syllabus prescribed
- 4. The School timings, vacations and mid-term holidays should be as prescribed by the Government from time to time.
- 5. That the qualified staff with in the age limits prescribed by the Government employees should be appointed as per the staff pattern and the appointment should be made as per G.O.Ms.No.1 Edn.(PS.2) Dt.01.01.1994.
- 6. That the records / accounts should be furnished to the District Educational Officer every year by 31st of May of the latest.
- 7. That the pay structure/ fee structure fixed by the Governing body should be get approved by the District Educational Officer every year.
- 8 That all the conditions prescribed in the G.Os and other orders which are not

specified in this order should be complied with.

- 9. That the school should not be closed without giving notice both to the parents / DISTRICT EDUCATIONAL OFFICER, and competent authority at least 6 months before.
- 10. That the school should be closed or permitted to be closed only from the te on which summer vacation declared.
 - That the society should submit proposals for Renewal of recognition sufficiently in advance i.e. at least 6 months before prior to the date of expire of this Provisional of recognition.
- 12. The management should constitute the Governing Body as per the rule 15 of G.O.Ms.No.1 Education, Dt.01.01.1994.
- 13. The Management should provide adequate, Library books, TLM furniture to the school.
- 14.The Management should observe clean & Green and Implement Govt. Instructions.
- 15. The Management should replace the unqualified teachers with qualified one.
- 16. The Endowment Grant should be converted into Joint account in favour of DISTRICT EDUCATIONAL OFFICER and Correspondent.
- at the Institution shall provide fire safety measures in the school as per Le No objection certificate from time to time up to the Renewal of recognition period ends.
- 18. That the management is informed that no thatched roof accommodation is allowed to run the school.
- 19. Proper and adequate sanitation facility shall be provided for students especially for girl students.
- 20. Proper and adequate safety measures shall be taken for children with in the school campus and also near the school premises.
- 21. The School shall follow traffic and safety guidelines indicated by the Police and fire services departments.
- 22. The Parent Teachers Associations meeting shall be conducted to sensitize the parents on the satisfaction of their children.
- 23. The School shall have first aid kit and the teachers shall be trained in first aid.
- 24. The Correspondent of the school concerned is hereby informed to file an affidavit every year to the effect that there is no deviation or violation of norms prescribed by the Government from time to time.
- 25. That the management shall obtain and submit the structural soundness certificate every year before reopening of the school for the academic year.
- 26. The School Van/Bus should be ensured road worthy for the transportation/mobility of school children.
- 27. The management should fulfil all the conditions stipulated in RTE Act.
- 28. The management should submit latest sanitary certificate and submit to the undersigned in every year.
- 70. The management should submit audit reports and administrative reports of the school every year to the undersigned.
