Now the Correspondent, **Global View High School, Sri Balaji Green City, Opp.Chokkapu Cheruvu, Ramabhadrapuram, Vizianagaram District** has submitted proposals vide reference 7th cited for recognition for the classes VIII to X (EM) for the academic years from 2023-24 onwards.

In the reference 9th cited, the District Educational Officer, Vizianagaram has verified the application and verification report of the Deputy Educational Officer, Bobbili for Recognition as per G.O.Ms.No.1, Education, Dated:01.01.1994 and its amendments issued from time to time and recommended for renewal recognition for the classes VIII to X (EM) from 2023-24 to 2030-31 for a period of 08 years.

As per the G.O.1st to 4th cited and as per the G.O.10th cited and as per the instructions of the Commissioner of School Education, A.P., Amaravathi vide reference 11th cited, the Regional Joint Director of School Education, Visakhapatnam who is the competent authority, is hereby accords renewal recognition to **Global View High**

School, Sri Balaji Green City, Opp.Chokkapu Cheruvu, Ramabhadrapuram, Vizianagaram District (UDISE Code:28121300616) without Grant-in-Aid now or in future for the classes from VIII to X (EM) for a period of 08 years from 2023-24 to 2030-31 subject to fulfilment of the following conditions.

- 1 That the society shall abide by the rules and regulations made by the Government or authorized officer from time to time.
- 2 That the Educational Institutions shall serve the needs of the locality more particularly.
- 3 The institution shall adopt the curriculum and syllabus prescribed by the Government from time to time.
- 4 That the school timings, vacations and mid-term holidays shall be followed as prescribed by Government from time to time.
- 5 That the qualified staff within the age limits prescribed by Government for Government employees shall be appointed by the management with own funds as per the staff pattern.
- 6 That the results of institution shall be satisfactory every year.
- 7 That the records / accounts shall be furnished to the District Educational Officer, every year by 30th September at least.
- 8 That the list of Governing Body shall be furnished to the District Educational Officer every year.
- 9 That the pay structure / fee structure fixed by the Governing Body shall be got approved by the District Educational Officer every year.
- 10 That all the conditions prescribed in the said G.O.'s and other orders which are not specified in this order shall be complied with.
- 11 That the school shall not be closed without giving notice both to the parents / District Educational Officer and competent authority at least six months before.
- 12 That the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.
- 13 That the society shall submit proposal for Renewal of recognition sufficiently in advance i.e., At least six months prior to the date of expire of the present recognition.
- 14 The management is informed that no thatched roof accommodation is allowed to run the School.
- 15 The management shall provide proper adequate Toilets / sanitation facility to the students & Staff.
- 16 Proper and adequate safety measures shall be taken for the students within the school campus and also near the school premises.
- 17 The school shall follow the traffic and safety guidelines indicated by the Police and fire services departments.
- 18 The parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the students.
- 19 The school shall have first aid kit and the teachers shall be trained in first aid.
- 20 That the management shall provide Ramps in the school building for differently abled children.
- 21 That the management of the school is hereby instructed to maintain Fire equipment in the prominent places of the school building.
- 22 That the management shall obtain the structural soundness certificate issued by the Executive Engineer, R&B / PRI / Samagra Shiksha every year before reopening of the school for the academic year and same should be submitted to the District Educational Officer through the inspecting officer without fail.
- 23 The Management is hereby informed to file an affidavit before April 30th of every year to the effect that there is no deviation or violation of norms prescribed by the Government from time to time.
- 24 That the management shall provide the Annual Administrative Reports for all the years of previous recognition period and same should be submitted to the District

- Educational Officer through the inspecting officer.
- 25 That the management shall provide the Annual Audit reports of this school which were audited by an authorized Chartered Accountant for all the years of previous recognition period and same should be submitted to the District Educational Officer through the inspecting officer.
- 26 The management should maintain Qualified and TET eligible teachers at all time. The management should be submitted Fire NOC of every year to the District Educational Officer through the inspecting officer concerned.
