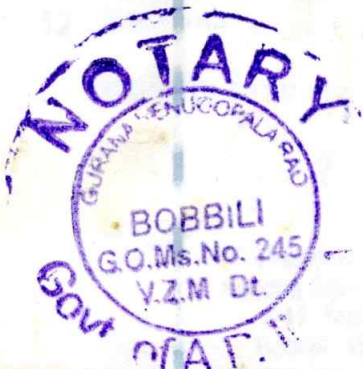

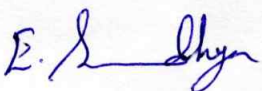
1. That Buddha Educational Society is a registered Society/Trust Under the XXI of 1860.
